



« The way I write, the way I produce knowledge texts, is based not on the idea that the text would be pretty, chic or desirable, but on a conception of the social sciences in dialogue with literary creation. Writing, for me, does not refer to fiction, but to the invention of forms, of research texts, the research relating both to the facts to be established, the sources which attest to them and the form by which they are reported. Research has forms and it is possible to renew them.» (Jablonka, 2024, p. 35)





2017 : experience of the contradictions that weave the accompaniment of unaccompanied minors = explore this tension by enrolling in university


2020 : first research : tensions between politics, technique and humanism

« Since the subjectivity of the researcher (whether unconscious, intuitive, assumed or reasoned) necessarily permeates his research, it seems important to me to bring to light the following, vital, visceral question, with which he identifies and without which he would only do scholarly work. It is necessary, for scientific reasons, to translate into general, socially appropriate terms, the intimate question that haunts the person who asks it; and, at the end of the journey, the development of knowledge relieves an obsession, heals suffering.» (Jablonka, 2024, p. 205-206)

Being listened to by my peers in this way, in a caring and non-judgmental climate Draperi, 2016, p. 71) had “the corollary of a lasting effect of memory reactivation” which subsequently promoted “the resurgence and the exploitation of ignored connections” (Lago & Surian, 2020, p. 157).




- ✓ A double influence, "marked by the feeling of parental fragility and suffering, associated with that of strength, courage and commitment" (Mathier, 2006, p.5).
- ✓ An "acute awareness of the fragility of democracy and republican values" (Mathier, 2006, p. 138-139)
- ✓ "Existence of a feeling of reinforced otherness and that of an exacerbated sensitivity to humanist values" (Mathier, 2006, p. 80)
- ✓ A duty of vigilance and resistance "to any totalitarian attempt" or "to any act flouting human dignity" (Mathier, 2006, p. 139)





The figure of the foreigner put of the test in social work

The figure of the foreigner put of the test in socialwork


The retrospective dimensions of history are used here to understand the current situation, and to frame the continuation of the research work in terms of forward-looking questions about professional practices





France, 1789-2002




Social thought as a theoretical referent



This conception of expected social representations as both products and processes leads us to cite the work of Kalampalikis and Apostolidis who wrote in a book chapter that « social thought is both constituted and constitutive, describing social reality as it is constructed through our interactions, actions and communication, and forming a thinking environment that determines our perception of reality and guides our actions » (2016, p. 74).








